

Vintage Knits for Modern Babies Contest Rules

How To Enter

To enter, submit a photograph depicting of a baby wearing a hand-made piece of knitwear with your name, physical mailing address, and the name and source of the pattern for the knit to CrafterNews@randomhouse.com between 12:01 AM EDT Monday, December 7, 2009, and midnight on January 9, 2010. NO PURCHASE NECESSARY. All entries must be created by and be the original work of the entrant, and must not violate the rights of any third party.

There is a limit of one (1) entry per person (regardless of whether a person has more than one e-mail address) per e-mail address (regardless of whether more than one person uses the same e-mail address) for the duration of the Contest. In the event of a dispute about entries submitted by multiple individuals using the same e-mail account, entry will be deemed to have been submitted by the authorized subscriber of the e-mail account used to enter the Contest at the actual time of entry.
