By letter dated July 10, 1959, Mr. Henry Roemer McPhee requested an investigation be made of James Smith Bush. Enclosed herewith is a summary memorandum of inquiries conducted by this Bureau concerning Mr. Bush.

An individual interviewed during the investigation of Mr. Bush, who requested that his identity not he disclosed, advised that although he had no personal inowledge of any misconduct on the part of Mr. Bush. Information had come to his attention through two personal friends of his, whose names he did not desire to be disclosed, that Mr. Bush had the reputation of being quite a ladies man. This person stated that his two friends had informed him that on one occasion in the openly propositioned a woman for a sexual affair and? that Mr. Bush had on several occasions had affairs.with 🖛 women while he, Mr. Bush, was married.

The informant stated that he had the distinct impression from both of his personal friends that dur to Mr. Bush's being a "ladies" man" he could not be trusted in a position involving trust and confidence since h could possibly be easily led astray by a beautiful woman.
